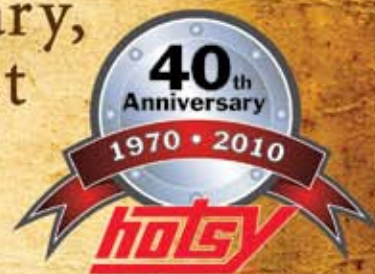

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Winners' names will be randomly drawn from eligible entries on June 4, 2010. The contest is sponsored by Hotsys Corporate, 4275 NW Pacific Rim Blvd., Camas, WA 98607 ("Sponsor").

(1) **ELIGIBILITY:** The Contest is open to legal residents of the U.S. and Canada only. Participants must be age eighteen (18) or older as of the date of entry to be eligible.
