## FIRST AID MEASURES

<b>Inhalation:</b>	Remove from exposure and get fresh air. Keep warm and at rest. Get medical attention immediately if artificial respiration is required.

Flush affected area with large amounts of water, then use soap or mild detergent and large amounts of water for 15-20 minutes to cleanse area. 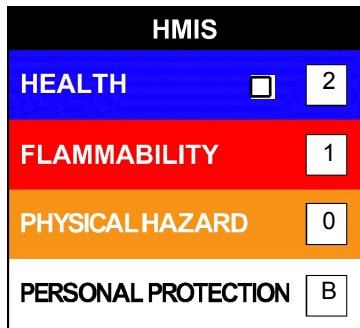
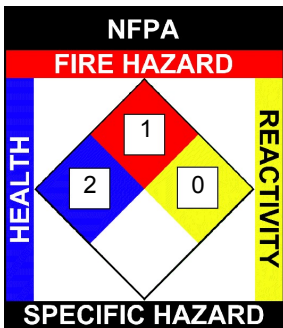
