<b>Inhalation:</b>	Remove from exposure and get fresh air. Keep warm and at rest. Get medical attention immediately if artificial respiration is required.
<b>Skin Contact:</b>	Remove contaminated clothing, jewelry and shoes immediately. Flush affected area with large amounts of water, then use soap or mild detergent and large amounts of water for 15-20 minutes to cleanse area. If skin is severely irritated or burned, get medical attention immediately.
<b>Eye Contact:</b>	Immediately flush eyes with large amounts of water occasionally lifting upper and lower lids for at least 15 minutes. Get immediate medical attention.

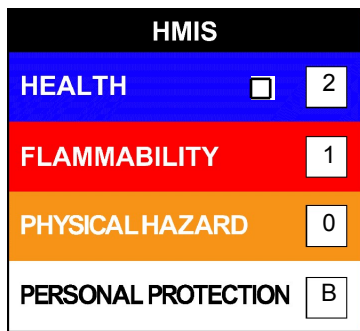
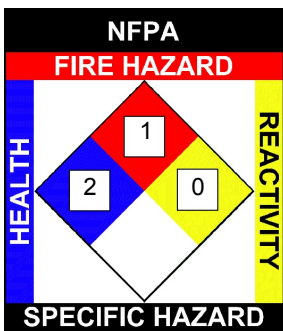
