<b>Inhalation:</b>	Remove from exposure and get fresh air. Keep warm and at rest. Get medical attention immediately if artificial respiration is required.

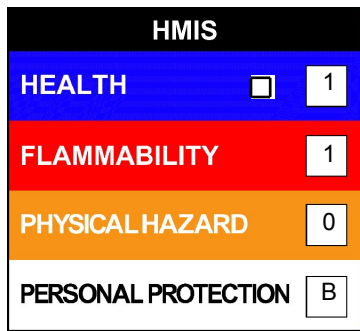
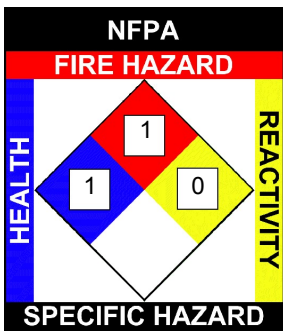
